TERMS AND CONDITIONS OF SALE

1. All business conducted between Confident Group and the customer shall be subject to the terms and conditions recorded herein.
2. Payment of all purchases are strictly 30 days.
3. If payment of any purchase made is overdue the purchase price for all purchases made by the customer from the company shall immediately become due, owing, and payable.
4. By signing these terms and conditions of sale, the customer consents to Confident Group doing a credit reference check of the customer and authorises Confident Group to contact the references provided.
5. Confident Group will be entitled to charge interest at a rate of 24% per annum in terms of the Prescribed Rate of Interest Act No. 55 of 1975 on the customers' overdue account.
6. Any date or time specified for delivery by Confident Group or the customer in respect of any sale, shall be an approximation and guide only. Confident Group endeavours to effect delivery on any date specified by it or agreed upon by it.
7. Notwithstanding anything herein before or elsewhere contained, ownership of the goods shall, always, remain vested in the Confident Group, until the customer has made full payment of the purchase price. No latitude or extension of time given to the customer shall in any way vitiate or novate the Confident Group rights hereunder. In the event of any default on the part of the customer, the Confident Group shall, without prejudice to any other rights it may have, and without notice, be entitled, on demand, to obtain return of the goods, in so far as payment for the goods has not been made in full. The customer also consents to a Court Order against it for the attachment and removal of such goods by the Sheriff of the relevant Court.
8. On receipt of the goods delivered to the customer by Confident Group or its agent, the customer must examine the goods delivered and ensure it correlates to the sample ordered.
9. The customer may return the goods ordered to Confident Group and receive a full refund of any consideration for those goods, if Confident Group has delivered goods to the customer and the customer did not have an opportunity to examine the goods before delivery; and the customer has rejected delivery of the goods as the goods are not of a type and quality reasonably contemplated in the agreement as well as in the case of a special order agreement, if the good do not conform to the material specifications of the special order. The goods contemplated in this section must be returned within ten business days after delivery to the customer or no refund will be made.
10. The customer may not return goods that have been supplied by Confident Group to the customer, at the customer's direction, if the goods have been partially or entirely disassembled, physically altered, permanently installed, affixed, attached, joined or added to, blended or combined with, or embedded.
11. The customer is alerted to the fact that all goods ordered with Confident Group are "special-ordered goods" as contemplated under the Consumer Protection Act No. 68 of 2008 and therefore all goods ordered by the customer are not returnable unless otherwise stated below or in terms of the Consumer Protection Act. A special ordered good as defined in the Consumer Protection Act means a good that a supplier expressly or implicitly was required or expected to procure, create, or alter specifically to satisfy the consumer's request.
12. In the event of Confident Group having to institute legal action against the customer, the customer shall be liable for all legal costs incurred by Confident Group on the scale as between attorney and own client including tracing costs. The Plaintiff or Applicant in any proceedings arising out of or in connection with these terms and conditions shall be entitled, but not obliged, to institute such proceedings in the Magistrate's Court. This clause shall constitute written consent in terms of Section 45 of the Magistrate's Court Act that the Magistrate's Court shall have jurisdiction over any proceedings arising out of or in connection with this contract.
13. These terms and conditions shall govern the contractual relationship between Confident Group and the customer and no other terms, conditions or provisions in any other form or manner or implied by Law shall be of force and effect unless reduced to writing and signed by Confident Group and the customer.
14. The customer shall notify Confident Group forthwith in writing of:
 - a. any change of address or any detail and particulars hereinabove.
 - b. any change in ownership or control of the customer including any share transaction or membership transaction affecting the majority ownership and control of the customer. Where a change of ownership of the customer has taken place, a new credit agreement will have to be signed by the new owners.
15. The customer agrees that its signature of its employees or any person purporting to represent it on the official delivery note or waybill of the Confident Group be sufficient proof of delivery of the goods from time to time.
16. The applicant chooses as its DOMICILIUM CITANDI ET EXECUTANDI for all purposes, the physical address stipulated on the covering page of this agreement.
17. The signatory by his signature hereto hereby binds himself/herself as surety a co-principal debtor for the payment on demand of all amounts owing by the applicant to Confident Group
18. A Certificate signed by any manager of Confident Group, whose appointment it shall not be necessary to prove, shall constitute prima facie proof for all purposes any amount due by the applicant to Confident Group.
